To advance safety and security within the EU requires research and innovation to strengthen the abilities of border protection and management. This includes area reconnaissance and surveillance (air, ground, sea), stable cooperation and data-exchange with foreign authorities, including interoperability capabilities with local, regional, national and international command-, control- and communication-centres as well as implementing solutions for border-protection, incident responding, risk-detection and crime-prevention. Further, to include is research on predictive policing and algorithm-based early warning applications, automated surveillance technologies using various kinds of sensors, while taking into account fundamental rights. While evaluating their impact and potential to enhance security efforts and solution, technologies and equipment should contribute to the integrity of those approaching external borders by especially land and sea.

Research should support the improvement of the integrated European border management, including through increased cooperation with candidate, potential candidate and EU Neighbourhood Policy countries. It will further assist EU efforts managing migration.
