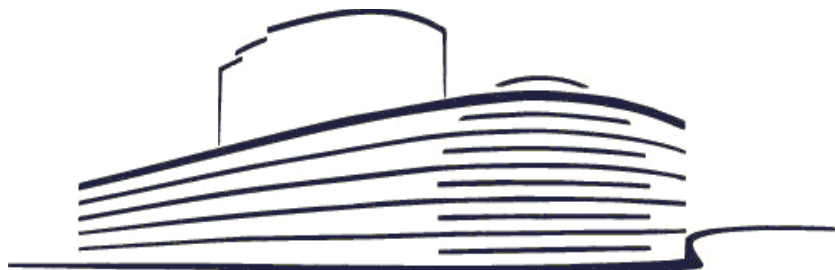

## 1. Resumption of the session

The session suspended on Friday 21 May 2021 was resumed.

## 2. Opening of the sitting

The sitting opened at 17.10.

## 3. Statement by the President

The President made a statement to mark the return of Parliament's plenary sitting to its seat, Strasbourg, after more than 15 months away owing to the COVID-19 pandemic. He stated that he saw the return as a sign of confidence and hope following the extremely testing times that our societies had endured. He pointed out that, in taking extraordinary measures and adopting new working methods, Parliament had been able to carry out its duties and exercise its prerogatives. He thanked the French authorities and the people of Strasbourg for their support and hospitality, and welcomed the Mayor of Strasbourg, who was in attendance in the Chamber.

## 4. Approval of the minutes of the previous sittings

The minutes of the sittings of 17, 18, 19, 20 and 21 May 2021 were approved.
