28b. Points out that the free trade agreement and temporary trade liberalisation mainly benefit one of the giants of the Ukrainian sector, MHP, which is owned by Yuriy Kosyuk; notes that this reinforces the country's monopolies, including through the European Bank for Reconstruction and Development's lending to this company, which totals one fifth of its lending to Ukraine in the past two years; stresses that these investments have allowed production to ramp up and that annual EU poultry imports from Ukraine have more than doubled since Russia's attack began two years ago; points out that MHP's owner has used letterbox companies in EU tax havens and currently uses two cutting companies, one based in the Netherlands and the other in Slovakia;
