COORDINATORS' DECISIONS

Meeting of 9 September 2024

1. Interpretation in committee meetings ('linguistic profile')

The coordinators approved the updated linguistic profile for the provision of interpretation.

2. Point allocation system for reports and opinions (including budgetary and discharge)

a) Point allocation system for reports and opinions

The coordinators decided by majority to continue the use of the points system that has been in use in the previous legislature.

- At the beginning of each half-term, each group receives 5 points for each full Member belonging to a political group;
- groups pay 5 points each time they nominate a rapporteur; 2 points each time they nominate a rapporteur for opinion;
- the group which has the most points remaining has the first choice about whether or not it wishes to claim the next report/opinion to be allocated;
- the secretariat provides an updated points table after each coordinators' meeting;
- points which are not spent by the end of the half-term are lost;
- if a Member changes from one political group to another in the course of a parliamentary half-term, s/he is entitled to take to her/his new political group the number of points corresponding to the remaining portion of the half-term minus the points that s/he may have already used, provided that the respective weight of the group has changed in the Committee.

Points should not be allocated to the non-attached Members, as this system applies to the entitlements of Members of political groups. This is without prejudice to the possibility of non-attached Members to be appointed as rapporteurs in committees on the basis of ad hoc decisions by coordinators.

b) Allocation system for budget and discharge procedures in particular

For the annual budgetary and discharge procedures, coordinators also decided in favour of the previous system (option 4 of the note), namely appointing the rapporteur each time and paying points respectively.

Reports

Ninth Report on Economic, Social and Territorial Cohesion, 2024

With regard to the designation of a political group that would appoint a rapporteur to draw up an own initiative report on the 9th Cohesion Report, the coordinators postponed their decision for their next meeting.

Proposals for new INI reports

The coordinators agreed that they need more time to look closely into all proposals for own-initiative (INI) reports, which have been already submitted or are about to be submitted by the groups, and agreed to decide together on the INI reports to be drawn up by the committee, including the 9th cohesion report, at their next meeting.

The coordinators agreed to follow the previous committee practice and (i) request authorisation to hold inter-parliamentary meetings on a case-by-case basis when the time is right, and (ii) continue to include, where possible, meetings with representatives of national parliaments in the programmes of REGI missions. They also took note of the proposal of the S&D coordinator to include exchanges with regional parliaments.

The coordinators took note of the invitation to political groups to submit proposals for public hearings in the first half of 2025 to REGI secretariat by 30 September.

8. Committee missions

Coordinators did not take a decision on a possible mission in 2024, and took note of the invitation to political groups to send their proposals on missions for 2025, including a short justification, to REGI secretariat by 26 September.

9. Visit of Portuguese Parliament

Coordinators took note of the upcoming meeting with the Portuguese delegation and agreed to explore ways of participating, in view of the risk that its timing overlaps with the confirmation hearing for Commissioner.

10. Nominations to STOA Panel

Coordinators decided to appoint Mr **Marcos Ros Sempere** as their REGI representative to the STOA Panel. They also took note of the invitation to political groups to send to REGI secretariat suggestions for future topics of STOA studies by 26 September 2024 eob.

11. Petitions network - Appointment of REGI Member

Coordinators took note of the invitation to political groups to submit nominations to REGI secretariat by 23 September 2024 to appoint two REGI Members for the **PETI Network** (one full and one substitute).

12. Gender Mainstreaming Network and Gender Equality Week

The coordinators took note of the invitation to political groups to submit nominations by 23 September 2024 to appoint 2 REGI Members to the **Gender Mainstreaming Network** (one full and one substitute). The coordinators also approved the Committee's gender mainstreaming action plan without modifications and took note of the invitation to political groups to submit their ideas on the **Gender Equality Week** (scheduled from 4 to 7 November 2024) REGI secretariat by 23 September 2024.

Coordinators took note of the invitation to political groups to submit by 23 September 2024 to REGI secretariat nominations for the REGI representative at the United Nations Convention on the Rights of Persons with Disabilities (**CRPD**) Network. Coordinators also took note of the invitation to political groups to submit ideas for the **Disability Rights Week** (scheduled from 2 to 8 December 2024) to REGI secretariat by 25 October 2024.

Coordinators took note of the invitation to political groups to submit nominations for the REGI representative to the meetings in ECoPP by 23 September 2024. Coordinators instructed the secretariat to inform the organisers of their request to avoid overlaps with the Strasbourg part-sessions.

- The coordinator of the Greens/EFA group submitted a **request for remote participation** of Ms Cristina Guarda to committee meetings until the end of the year, including the confirmation hearing of the Commissioner-designate. The coordinators agreed to conduct the committee meetings in **hybrid mode** until the end of 2024 allowing the remote participation of Ms Guarda. However, the Chair stressed that remote participation is not possible to the confirmation hearings for Commissioners.
