1. Calendar of REGI committee meetings in 2025

The coordinators approved the proposed meeting calendar but, following the S&D coordinator's concern about Monday 22 September, asked the secretariat to explore alternative dates.

2. Points table

The coordinators took note of the current points table.

3. Referrals

Opinions and letters

A) BUDG own-initiative report entitled ‘A revamped long-term budget for the Union in a changing world’

The coordinators agreed that the Chair or a Vice-Chair would be the rapporteur for this non-legislative opinion (0 points).

B) Budgetary discharge opinion

The coordinators agreed that the Chair or a Vice-Chair would be the rapporteur for this budgetary discharge opinion (0 points).

C) Mobilisation of the European Globalisation Adjustment Fund to support workers made redundant following an application from Belgium — EGF/2024/001 BE/Match-Smatch

The coordinators approved the attached letter to BUDG Committee.

4. Own-initiative reports

The coordinators decided to request authorisation for the five own-initiative reports listed below, assigning them to the political groups indicated in parentheses:

1. 9th Report on economic, social and territorial cohesion (EPP, 5 points)
2. Strengthening rural areas in the EU through cohesion policy (ECR, 5 points)
3. The role of cohesion policy in the European plan for affordable housing (S&D, 5 points)
4. The role of cohesion policy in supporting the just transition (Renew, 5 points)
5. Possibilities for simplification of cohesion funds (Greens/EFA, 5 points)

The coordinators left in reserve the own-initiative report on “Outermost regions, islands and cohesion policy”, agreeing, in principle, to allocate it in the future.

5. Confirmation hearings of Commissioners-designate

The Chair informed and the coordinators took note of the decision of the Conference of Presidents (CoP) according to which:

REGI is the only responsible committee at the upcoming confirmation hearing of EVP-designate Raffaele **Fitto** (Cohesion and Reforms); six committees are invited (TRAN, BUDG, AGRI, PECH, EMPL and ECON);

REGI is an invited committee at the confirmation hearings of EVP-designate Teresa **Ribera** (Clean, Just and Competitive Transition) and Commissioner-designate Dan **Jørgensen** (Energy and Housing)

The confirmation hearings will be held from 4 to 12 November; the exact programme will be decided next week in Strasbourg (proposed by Conference of Committee Chairs on Tuesday 8/10 and approved by CoP on Thursday 10/10).

The coordinators also noted that the REGI written questions were being finalised in written procedure.

6. Public Hearings in 2025

The coordinators decided to submit the following proposals for public hearings to the CCC for authorisation:

Depopulation Challenges in European Regions
Towards a European Plan for Housing: Perspectives on urban and rural
Enhancing Cohesion Policy for Outermost Regions and Islands: Navigating
Challenges and Seizing Opportunities Post-2027

7. Committee missions in 2025

The coordinators decided to approve the following list of missions for 2025:

Midlands - North West of Ireland (provisional* date: week 9, 24-26 February 2025)
Jämtland-Härjedalen - Sweden (provisional date: week 22, 26-28 May 2025)
Ionian Islands - Greece (provisional date: week 38, 15-17 September 2025)
North Eastern Poland (provisional date: week 44, 27-29 October 2025)

In principle, the coordinators also agreed on the following list of destinations for 2026:

Ukraine border - Slovakia,
Puglia - Italy,
Madeira - Portugal.

** Provisional dates are required for the authorisation request to the CCC. In accordance with the respective Bureau Decision, committee missions should take place in the weeks set aside for external parliamentary activities, i.e. the green weeks, and they may not exceed, in principle, three days.*

- European Community of Practice on Partnership (ECoPP): Mr Vladimir Prebilič (Greens/EFA) as a full member and Mr. Paulo Do Nascimento Cabral (EPP) as a substitute

9. Topics for future STOA studies

The coordinators agreed to submit all proposed studies to STOA.

10. REGI input to Gender Equality Week and Disability Rights Week

a) Gender Equality Week (4-7 November 2024)

The coordinators agreed to hold the presentation of the upcoming CEMR study on "Women in Politics" and noted that the gender equality week might be moved from November to December due to the confirmation hearings of Commissioners-designate.

In addition, the coordinators agreed in principle that the Networking and Strategy Event on "The Right to stay for young women in remote areas" would be considered next year (2025).

b) Disability Rights Week (2-8 December 2024)

The coordinators were reminded of the invitation to the political groups to submit their ideas by 25 October.
