1. DECISIONS TO BE TAKEN

1.1. Approval of the agenda

The draft agenda was adopted.

1.2. Announcements by the Chairwoman

1.3. Nominations of rapporteurs/draftspersons

- **2023 discharge: General budget of the EU - Commission**

Decision: The TRAN Coordinators decided to allocate this opinion according to rotation system to EPP (0 point) and to work on the opinion in EN only.

- **2023 discharge: General budget of the EU - Decentralised Agencies**

- **2023 discharge: General budget of the EU - Joint Undertakings**

Decision: The TRAN Coordinators decided to allocate those opinions together according to rotation system to EPP (0 point) and to work on the opinions in EN only.

- **Opinion to BUDG INI report ‘A revamped long-term budget for the Union in a changing world’**

Decision: The TRAN Coordinators decided to allocate this opinion according to rotation system to S&D (0 point).

- **NLE Report Conclusion of an agreement between the European Union and the government of the People's Republic of Bangladesh on certain aspects of air services**

Decision: The TRAN Coordinators decided to allocate this NLE report according to the rotation system for international agreements to EPP (0 point).

1.4. Budget standing team

Decision: The TRAN Coordinators decided:

- to allocate the TRAN budget opinions and the budgetary amendments to Budget 2026 to EPP (Rapporteur Mr Falca);
- to endorse in principle the idea of a Budget standing team with a degree of flexibility for the political groups.

1.5. Hearings of Commissioners-designate

Decision: TRAN Coordinators decided to start work on the draft oral questions that the Chair (or a Vice-Chair) will ask, on behalf of TRAN, to the four hearings of Mr Fitto,

Mr Kubilius, Ms Ribera and Mr Hoekstra; to this end, the TRAN Coordinators, following the receipt of the answers to the written questions, should send their proposals for OQs to the Chair and the Secretariat, who will prepare a draft to be discussed with the political groups and endorsed by the TRAN Coordinators ahead of the hearings;

1.6. Tourism task force (TTF)

Decision: The TRAN Coordinators endorsed the suggested working arrangements for the TTF with the following changes regarding leadership: the TTF and its Steering Group shall be chaired by the TRAN Chair. The TTF Steering Group shall be composed of the TRAN Bureau and one Member from each of the following political groups: EPP, S&D, ECR and Renew.

1.7. TRAN mission to Marseille 28 - 30 October 2024

Decision: The TRAN Coordinators endorsed the list of participants and the draft programme.

1.8. TRAN missions for 2025

Decision: The TRAN Coordinators confirmed the first 2025 TRAN mission to Aragon, Spain with 6 members (excluding the Chair) to take place from 24-26 Feb 2025; the political groups are invited to communicate the names of their participants as soon as possible;

The TRAN Coordinators further decided that the following TRAN missions shall take place in 2025:

- February green week (week 9) - Spain Argon*
- May green week (week 22) - Malta*
- July green week (week 30)- Ireland*
- September green week (week 38) - Poland*
- October green week (week 44)- South Korea*
- possible ad-hoc TRAN delegation to IMO or ICAO could also be organised should there be any appropriate events to attend in the calendar of these organisations.*

1.9. Public Hearing on passenger rights package

Decision: The TRAN Coordinators endorsed the draft programme and the list of speakers (with no expenses to be covered). The hearing will take place on Monday, 18 November 2024.

1.10. TRAN activities with National parliaments - first half of 2025

Decision: The TRAN Coordinators decided not to organise any event with National Parliaments for the first half of 2025.

1.11. Nominations for the French National Council of the Sea and Coastal Regions (CNML)

Decision: The TRAN Coordinators endorsed the nomination of François KALFON (S&D) and Jean-Marc GERMAIN (S&D) as the TRAN candidates for the two positions offered by the CNML. The final decision about the EP representatives will be taken by the EP President on the basis of the nomination by the three committees involved (TRAN, ENVI, PECH)
