The main topics during the event were security and global engagement, turning global transformations into generational opportunities, building inclusive societies, clean economy, youth participation, addressing challenges of the digital age, countering authoritarianism and hard-right, and shaping a just future.</p> <p>The event took place on 20th and 21st of September, but I was in Montreal between 19th and 22nd of September (19th of September and 22nd of September were the days of the arrival and the departure). The covered subsistence expenses were meals.</p>
