







# EU-Bahrain Conference "Broadening the Tent: Freedom of Religion and Belief" 30-31 May – 1 June 2022 – Gulf Hotel, Manama

### **Concept Note**

The emergence of the Human Rights framework has been a long and painful process, punctuated by tragic milestones made of revolutions and massacres, specifically around religious issues. The emerging awareness about freedoms, back in the 17-18<sup>th</sup> centuries of the common era, has been rooted in the need to assert and guarantee freedom of religion, at the core of what would become philosophical liberalism. The right to have a religion different from that of the majority, to change from religion and not face persecution and death sentences, was brought forward by key philosophers of the Enlightenment. But they quickly figured out that this Tent needed to be enlarged to incorporate related freedoms.

Freedom of Belief (and Thought) imposed itself very quickly. And one can say that freedoms of religion and of belief as well as thought are the only absolute freedoms. All other freedoms face certain limitations, or their expression can be restricted for some specific grounds of higher interest (such as health, security, protection of the individual against themselves), but no one can limit or even forbid individuals to think and believe whatever they wish, in their inner selves. Same goes for religion: this freedom is considered to be limitless when it comes to beliefs, world views about life, death and destiny even if some individual and collective religious concrete practices might face some restrictions in specific circumstances. Freedom of expression has later been correlated to these founding freedoms as it has been understood that religion is not only a matter of individual beliefs and practices, but is intrinsically linked to life in and with a community, which requires to be nurtured by discourses, theology, exchanges, pastoral care and transmission of knowledge, which requires a certain level of freedom of expression.

Although the growing secularisation of political and civic spaces in Western societies have led many people to forget the centrality of FORB in the development of the architecture of Fundamental rights and civil liberties, it is not by coincidence that EU institutions put such an emphasis on their promotion and defence, both within Europe and on the global stage.

This is where the organic and original experience of the Kingdom of Bahrain in enshrining religious freedom as key feature of its society, culture and way of life, and, increasingly, of its regional and global public diplomacy, finds a great common ground for concerted efforts with the EU. As said above, freedom of religion is fundamental, but freedom of religion concerns only those who have a religion. It leaves growing numbers of people with thoughts and beliefs out of protection in increasingly complex societies, where everybody is exposed to and influenced, to a certain degree, by multiple (a)religious, spiritual and philosophical world views. This massive anthropological shift is resulting, among others, from broadening access to higher education, arts and literatures, international travels and social media, and even more so in the aftermath of the Covid pandemic which has brought so many people to recast the meaning of their lives.

The limits of the Tent need to encompass freedom of belief (and thought), to ensure that people are protected whatever their beliefs, including the facts of not holding beliefs, of changing beliefs on the way, of holding minority beliefs within one's own religious community, etc. Non-religious or a-religious









forms of spirituality are blossoming, next to forms of agnosticism and atheism, while new forms and practices within traditional religions are emerging and modifying the mainstream, maybe at higher speed than in the past centuries or millenaries. The deepening of **FOR** to **FORB** seems to become naturally embraced by the Kingdom of Bahrain, putting the Kingdom on the central stage of this conversation among the GCC where such notions tend to be left aside or, not to say outrightly discarded, against the tide of a massive trend on the global stage. A trend that is, however, still facing considerable setbacks in various places where FORB is being challenged or even curtailed, whereas it has not even yet been granted to people in some countries.

It is by no means an easy journey for any society. The Kingdom of Bahrain's specific tradition of openness and tolerance towards religious diversity, rooted in a context radically different from the EU's, could provide a wonderful opportunity for mutual exchange and support in showing how societies coming from different historical, religious and philosophical backgrounds, come to parallel conclusions and efforts to broaden the Tent of FORB — reminding that the core protection they guarantee is granted to individuals, not to the religions or belief systems per se, which, by themselves, are abstractions that cannot be hurt, violated or tortured — contrary to human beings.

The three-day meeting will bring together Bahraini and European policy and decision makers as well as civil society representatives from faith/belief-based sectors to a structured dialogue to better understand their respective journeys regarding FORB, how they practically encompass and work with diversity of religions and beliefs and how both societies could cooperate to reinforce the respect of FORB at the regional and global levels.

### **Expected outcomes**

Through concrete networking activities, visits and structured dialogue, participants are expected to:

- Better understand the EU's and Kingdom of Bahrain's respective histories and perspectives on FORB;
- Establish links with relevant actors on both sides, among one's own cluster of activity and across clusters (policy making; decision making; civil society action; advocacy);
- Explore potential venues for further activities and cooperation in the framework of the EU-GCC dialogue or other frameworks, including at State and civil society level;
- Experience first-hand a practical inter-convictional experience in policy making on promoting and strengthening FORB at regional level.

- Al Fateh Grand Mosque, one of the largest Mosques in the world, at over 6,500 square meters and able to accommodate 7,000 worshippers
- A wonderful insight into the diversity of the ancient worship traditions of the Shia community visiting two famous Mataams
- Mataam Al Qassab, a Bahraini Shia Mattam
- Mattam Al Ajam, a Persian Shia Mataam
- Our Lady of Arabia Cathedral, the largest Catholic Cathedral ever built on the Arabian Peninsula, opened in December 2021
