# MEP China visit 'People to People cooperation for prosperity and friendship'

14 - 22 July 2017 (incl. flights)
Beijing, Zhengzhou, Nanjing and Yancheng



### **Background of the initiative**

1. Starting the cooperation 2007 - 2015

In the legislative period 2007 - 2014, the EPP Group in the European Parliament initiated a pilot project on the global aspects of cohesion policy. With their financial support, different concrete cooperation initiatives between the EU and China were set up, for example in the framework of the EC World Cities programme.


In this context, and in his capacity as EPP-Regi coordinator, Lambert van Nistelrooij organised and participated in several official meetings in the European Parliament. (For more information, see the <u>'Report on EU-China policy cooperation 2006-2015</u>").

Since the signing of the Memorandum of Understanding with the EU in 2004, we supported the European cooperation with the Chinese National Development and Reform Commission; this cooperation is now an integral part of the <u>EU-China 2020 Strategic Agenda for Cooperation</u>. This preparation has led to several projects that are at stake now.

In addition, Lambert van Nistelrooij also worked on improving the relations with the Chinese community in The Netherlands, in close cooperation with the Dutch Chinese Chamber of Commerce (DCCC).

In **2011**, Lambert van Nistelrooij and the DCCC could arrange the first EP working visit to China, hosted by the China Zhi Gong Party of the Overseas Chinese. Three Members of the European Parliament accepted this invitation and took part.

In **2015**, Lambert van Nistelrooij, Franc Bogovic and the DCCC could arrange a second working visit to China, hosted by the China Zhi Gong Party of the Overseas Chinese. Seven Members of the European Parliament accepted this invitation and participated in a working visit to Beijing, Nanjing and Shanghai. Mr. Woo, the former president of the Dutch Chinese Chamber of Commerce has participated in both visits.

#### 2. 2017 co-initiative Lambert van Nistelrooij and Franc Bogovic

We are pleased to initiate a working visit to China in **2017**, on the basis of the positive results and friendships of the two earlier visits of the European Parliament. This time, the delegation will be hosted by the <u>Chinese People's Association for Friendship with Foreign Countries (CPAFFC)</u> and the Dutch Chinese Chamber of Commerce (DCCC). The CPAFFC is among the first organisations engaged in people-to-people diplomacy of the People's Republic of China. The understanding and friendship between peoples are the foundation of the relationship between countries. The CPAFFC contributes to the implementation of China's independent policy of peace, inspired by the five principles op peaceful coexistence. It serves as a bridge with the support of the Chinese government and all sectors of society in China and abroad. It carries out people-to-people friendship work in a broad, multi-level manner, enhancing understanding and strengthening cooperation between countries.

This year's study visit is also the outcome of several visits to the European Parliament and the European Commission in Brussels of Chinese who are living in Europe since many years. On 26 January 2016, Chinese citizens from Zheng Zhou and Henan visited Brussels. These Chinese citizens living in Europe are organised in the Wencheng umbrella, which works in the interest of the Chinese people living in different countries throughout the European Union.

#### 3. Goals of the 2017 working visit

The working visit will start on 15 July and ends by 22 July 2017. After Beijing, we will visit Zhengzhou, Nanjing and Yancheng.

The program covers international cooperation between European regions and cities and their Chinese counterparts in the Henan region. Europe has strongly supported the role of citizens in their regions and cities, through the principles of subsidiarity, partnership and shared responsibility. The intensive EU-Chinese cooperation in the field of Urban and Regional Policy in recent years has been fruitful and is a great basis for our visit.

In this framework, we will discuss interregional cooperation. The province of Henan has seen fast economic and social development in recent years. We will discuss developments in the fields of research, development and innovation as well as in agro-food, telecommunications, automotive, transport, energy, and urban social development. The region of Henan has a clear wish to strengthen cooperation with EU-regions and cities. We are open to support such wishes and will work on the necessary contacts in Europe.

## 4. Rules for participation in the trip for the Members of the European Parliament:

- a) The final list of participants, including a CV and picture, is sent to the Chinese host CPAFFC, after their formal invitation has been received.
- b) MEP's will cover their flight costs from their article 22 IMSM budget line ("additional travel"). We will participate with at least 10 members of the parliament from several European countries.
- c) Our hosts in China will take care of and cover local transportation, and 7 nights of accommodation.
- d) A valid passport and a visa are required. Members have to apply for a Chinese visa immediately after receiving a formal invitation by the CPAFFC.

#### 5. Further preparation

After you have confirmed your interest in participating, you will be invited to some specific actions:

- A preparatory meeting with the participating Members of Parliament in June 2017 (tbc);
- To come forward with your wishes regarding completing the programme of the visit.



#### Research and innovation

EU-China Summit: new flagship initiatives in research and innovation. 2 June 2017 The European Union and China will boost their research and innovation cooperation with a new package of flagship initiatives targeting the areas of Food, Agriculture and Biotechnologies, Environment and Sustainable Urbanization, Surface Transport, Safer and Greener aviation, and Biotechnologies for Environment and Human Health.

EU-China Summit: moving forward with our global partnership, 2 June 2017

In the field of research and innovation, the European Union and China have agreed

to boost their <u>cooperation</u> with a new package of flagship initiatives targeting the areas of food, agriculture and biotechnologies, environment and sustainable urbanisation, surface transport, safer and greener aviation, and biotechnologies for environment and human health. These initiatives will translate into a number of topics for cooperation with China under <u>Horizon 2020</u>, the EU's funding programme for research and innovation. The 3rd **EU-China Innovation Cooperation Dialogue**, cochaired by Carlos **Moedas**, Commissioner for Research, Science and Innovation, and Wan Gang, China's Minister of Science and Technology, took place in the margins of the Summit. Both sides agreed on the **renewal of the EU-China** <u>co-funding mechanism</u> for research and innovation for the period 2018-2020, and on its application to future SME cooperation and to support start-ups. Both sides also confirmed their commitment to improving framework conditions, notably reciprocal access to Science and Technology and Innovation resources, and to promoting open access to publications and research. The European Commission's science and knowledge service, the Joint Research Centre (JRC), under the responsibility of Tibor Navracsics, Commissioner for Education, Culture, Youth and Sport, and the Chinese Academy of Sciences signed an overarching Research Framework Arrangement, building on their longstanding and fruitful cooperation in the field of remote sensing and earth observation. The objective of the agreement is to expand their collaboration and develop new scientific approaches in key areas, such as air quality, renewable energy, climate, environmental protection, digital economy, regional Innovation policy and Smart Specialisation. #### Regional and urban cooperation

Commissioner Creţu meets Vice Chairman Hu in EU-China 2017 Summit event, 6 June 2017.

The Commissioner and the Vice-Chairman reviewed recent cooperation actions on regional and urban policy, and the plans for next steps, notably the recent launch of the EU-China city-to city component of the EU's new International Urban Cooperation programme. In the presence of the Commissioner and the Vice Chairman, nine cities - 5 from China and 4 from the EU, with Prague set to join the IUC programme as the fifth EU city - signed a Joint Declaration committing them to the IUC programme and to promoting longer-term cooperation on sustainable urban development themes.

<u>Joint Declaration between pilot cities for EU-China Regional and Urban Policy Cooperation supported by the International Urban Cooperation Programme, 31 May 2017.</u>

On 31 May 2017, the 10th EU-China High-Level Dialogue on Regional Policy was held in Brussels. As part of the implementation of the EU-China 2020 Strategic Agenda for Cooperation, regional and urban policy cooperation will be intensified, based on amicable consultation among, respectively, the pilot cities of China and EU selected for 2017. The cities concerned are, in the first instance, Zhengzhou, Chongqing, Shantou, Jingyue High-tech Zone of Changchun, Longyan, Agii Anargyri-Kamatero, Mannheim, Burgas, Màlaga, Prague (hereinafter referred to as "IIIC cities").

12th High Level Dialogue on Regional and Urban Policy Cooperation A Side Event of the EU-China Summit, Agenda, 31 May 2017.

Regional policy: EU - China, European Commission, DG REGIO (this page contains many links)

On 15 May 2006, a Memorandum of Understanding (MoU) on regional policy cooperation was signed with the <u>Chinese National Development and Reform Commission</u> to exchange information and best practices on experiences in setting up and implementing cohesion policy.

The exchange programme known as CETREGIO (Chinese European Training on Regional Policy) has created strong links between EU and Chinese cities and regions. In the period 2010-2014, 220 Chinese decision makers from all 31 provinces have shared experiences and visited good practices in more than 45 regions of 17 EU Member States.

China was one of the four non-EU countries selected in 2015-2016 to participate in the EU regional and urban policy action in the field of international cooperation, known as <u>World Cities</u>); which pairs the cities of Wuhan-Barcelona (ES); Chengdu-Dublín (IE); Guangzhou-Lyon (FR); Shantou-Andalucía (ES); Tianjin-West Midlands (UK). The action proved highly successful, including from the point of view of producing new commercial opportunities for European and Chinese business.

A new programme will be implemented from 2017 as part of the actions under the <u>International Urban Cooperation programme</u> (IUC) to scale up and take forward previous successful cooperation between EU and Chinese regions and cities.

(China is facing considerable regional development disparities between the booming coastal regions, the underdeveloped Western parts of the country and the decline of traditional heavy industry in the North East and more general income disparities, particularly in relation to the urban/rural divide.)

EU-China cooperation on regional policy, Perspectives in Science, March 2016.

Although the European Union and China are different in terms of area, population, economic, social, political and cultural development, both of them have to face similar challenge – the significant regional disparities and unbalanced regional development. Based on this the EU-China cooperation on regional policy has been launched and there is huge potential to develop mutual learning initiatives to allow their regions developed.

Seeing the People's Republic of China through the Eyes of Montesquieu: Why Sino-European Collaboration on Eco City Development Suffers from European Misinterpretations of "Good Governance", Sustainability, 7 February 2017.

China faces a number of impressive challenges in dealing with climate change: rising energy use, growing emission levels of greenhouse gases, dangerous levels of air pollution over cities and low resilience against flood and drought. Sustainable urbanization has been adopted as a keyword in handling these challenges. The Chinese central government has undertaken a variety of measures, including the launch of large Sino-European programs to learn from 'developed nations'. In the wake of these partnerships, a great variety of cross-national and cross-city agreements were signed. Sino-European cooperation does not often run as smoothly as initially hoped because of diverging interests, cultural misunderstandings and practical limitations. In the background, a mismatch in normative conceptions Chinese and European participants have of 'good governance' plays a role.

#### **Energy policy**

EU-China Summit: moving forward with our global partnership, 2 June 2017.

Following the EU-China **High Level Energy Dialogue**, which took place this morning, Commissioner for Climate Action and Energy Miguel **Arias Cañete** and Mr Nur Bekri, Vice-Chairman of the National Development and Reform Commission and Administrator of the National Energy Administration of China signed the <u>Work Plan 2017-2018</u> of the Technical Implementation of the EU-China Roadmap on Energy <u>Cooperation</u>. This <u>Roadmap</u>, agreed in June 2016, commits both sides to tackling common energy and climate challenges, including security of energy supply, energy infrastructure and market transparency. The Roadmap lays the foundations for sharing best practices with regards to energy regulation, demand and supply analysis, energy crisis, and nuclear safety, as well as grid design and the integration of renewable energy into the electricity grid.

The EU-China Energy Cooperation. An Institutional Analysis, EIAS, February 2017. As one of the components of the EU-China relations, the EU-China energy relationship has experienced an evolution of institutionalization for over two decades. Now, an EU-China energy cooperation institutional framework has been constructed. These institutions have been playing a significant role in helping EU-China energy cooperation by promoting bilateral dialogues and fostering cooperation projects. However, they still face some flaws. The EU and China should continue taking the

construction of institutions seriously, and commit to optimize the institutional framework to make it more representative, pragmatic and efficient.

The move prompted a Chinese Foreign Ministry spokesman to publicly thank Greece "for upholding the correct position." EU diplomats and rights groups, however, were less than pleased. Human Rights Watch and nine other groups issued a statement saying the EU's credibility was being battered by its inability to adopt a coherent position on China's human rights record. In an email interview, Rem Korteweg, head of the Europe in the World Unit at the Clingendael Institute in the Netherlands, explains how Chinese investment in Greece has facilitated closer bilateral relations, turning Greece into a reliable friend.

#### Further comments and analysis on EU-China relations

Can the EU and China act together? Europe's world, 23 June 2017.

But it is also apparent that the EU and China cannot patch things up easily. The recent EU-China summit in Brussels made this fact abundantly clear. Because of the EU's refusal to grant market economy status to China an expected EU-China joint declaration on climate change was not agreed. Instead, the focus during the summit shifted to deep differences between China and the EU. Negotiations on an EU-China investment agreement stalled; the EU continues to deplore limited market access and Chinese dumping, especially in the steel sector. EU Trade Commissioner Cecilia Malmström was critical of Beijing: "The welcome commitments from [China] about liberalization have not been matched by concrete action".

Ambivalence among EU members yields to China on human rights, Asia Times, 29 June 2017.

After demonstrating unity for the protection of European industries against Chinese unfair market practices, the European Union has failed to agree on an effective approach to the problem of human rights abuses in China. The EU and China held the 35th round of their human rights dialogue in Brussels last week. The two-day meeting, attended by low-level government delegations on both sides, came after Greece's decision to block an EU declaration at the recent session of the United Nations Human Right Council condemning Beijing's human-rights record.

Commentary: It's right time for China, EU to deepen cooperation, Xinhua, 5 July 2017

With the 12th G20 summit on the horizon, it's the right time for China and the European Union (EU) to deepen ties, especially in promoting free trade and tackling climate change.

For the time being, Donald Trump's decisions on defence and trade have not been so significant as to trigger a realignment of relations between the US, China and the EU.
