

## 19<sup>th</sup> Meeting of the Editorial Board of the IPCC Emission Factor Database (EFDB)

12 April - 28 May 2021  
Virtual meeting

### Summary of the meeting

The 19<sup>th</sup> Meeting of the Editorial Board (EB19) was held virtually in April-May 2021. The EB19 was opened by the IPCC TFI Co-Chairs through a written communication to all participants on 12 April 2021 and took place in a series of online sessions of sectoral break-out groups (BOGs) in April-May and a closing plenary on 28 May 2021. The meeting was attended by Editorial Board members (31 out of 35), Co-Chairs of the IPCC Task Force on National Greenhouse Gas Inventories (TFI) and members of TFI Technical Support Unit (TSU).

Key objectives of the EB19 were:

- To consider outstanding and new data proposals
- To discuss the EFDB population and improvements

The EB19 was held in parallel with the 18<sup>th</sup> Expert Meeting on Data for the IPCC EFDB (18<sup>th</sup> Data Meeting) which was focused on data for Energy sector. The 18<sup>th</sup> Data Meeting (DM18) was attended by Editorial Board members of Energy sector and experts/data providers. The Editorial Board:

- considered data proposals including those provided by experts/participants to the DM18. Total 237 data were accepted for inclusion into the EFDB and 26 data for publication on the “Extra page” <https://www.ipcc-nggip.iges.or.jp/EFDB/otherdata.php> at the EFDB website.
- considered the updated information on EFDB population (e.g., results of review/analysis of data in the database, status of data proposals considered) reported by TSU.

- considered the activities implemented (e.g., improvements in user interface) and activities planned for the EFDB (e.g., new search/filter options, update of User Manual) presented by TSU.

The meeting was closed by Co-Chairs of the IPCC TFI thanking all participants for the successful outcomes.
