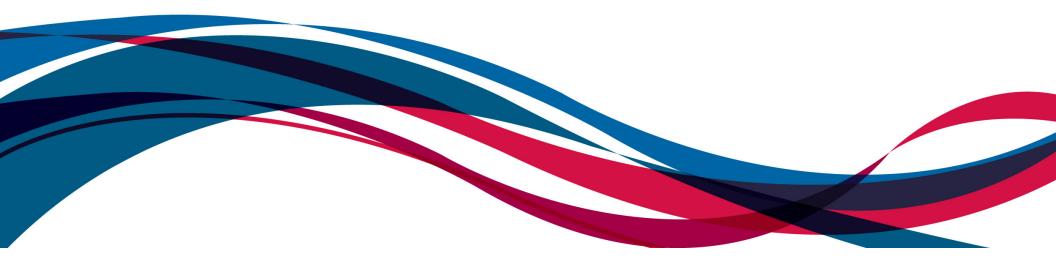



# **TY2024 Shutdown/Cutover**

## **IRIS Production**

Taxpayer Portal and A2A for all transmissions

- Shutdown began on December 03, 2024, at 12:00 a.m. Eastern time.
- Please do not attempt to access the IRIS Production environment via the Application to Application (A2A) and/or Taxpayer Portal channels during the shutdown/cutover period.
  - This includes corrections and replacements.
- Filing Season 2025/Tax Year 2024 will open January 10, 2025, at 9:00 a.m. Eastern time.
  - Please monitor the IRIS Status page for any updates.

#### Get started

To use the IRIS Taxpayer Portal, you need an IRIS Transmitter Control Code (TCC). This 5-digit code identifies your business when you e-file forms. It can only be used for IRIS.

## **IRIS ATS Reminders**

- Software Developers must pass IRIS ATS for the form series and tax year(s) that the software package(s) will support. Use the A2A software developer TCC to transmit to the ATS environment.
- Transmitters must pass a one-time communication test for the form series they will file. Use the A2A Transmitter TCC for the communication test.
- The transmitter name and EIN must match the TCC application. Do not use TINS with 000 in the Transmitter group.
- ➢ IRIS ATS for TY24 opened on November 4, 2024.
  - ➤ Tax Year 2024 is the current year in IRIS ATS.
  - ➤ Tax Year(s) 2023 and 2022 will be accepted as prior year returns.
- If you wish to have your Software tested and reviewed for a prior year, you must use the schema for that year.



# **Maintaining your TCC Application**

- Once you have completed the IRIS TCC Application process and received your TCC, it is important that you keep your account up-to-date. This includes:
  - Reviewing your TCC Application periodically.
  - Ensuring proper individuals are identified on the application.
  - Update as necessary by adding any new Responsible Officials or Contacts.
  - Updating any address changes needed both business and mailing.

# **TCC Application Updates**

- Effective December 9, 2024, the Information Returns Application for TCC and the Information Returns Intake System Application for TCC were updated to include:
  - S-Corporation as an option for Business Structure.
    - > This selection will allow for a single responsible official and contact.





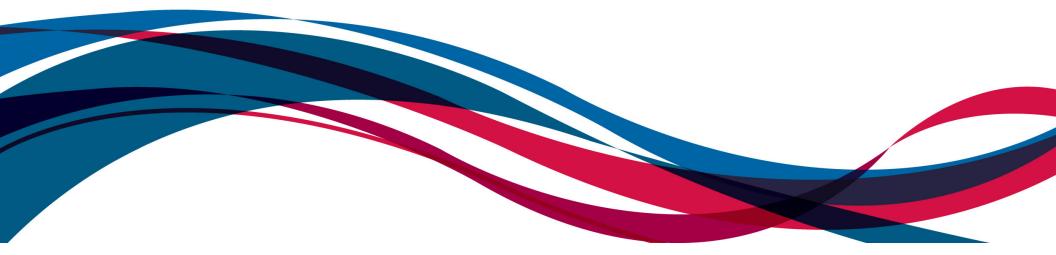
- Calendar years 2024 and 2025 will be regarded as the final transition period for the minimum reporting threshold for Form 1099-K, Payment Card and Third-Party Network Transactions.
- Third party settlement organization (TPSO) will be required to report payments in settlement of third-party network transactions when the amount of total payments for those transactions is:
  - Calendar year 2024 (TY24/PY25): gross amount exceeds \$5,000
  - Calendar year 2025 (TY25/PY26): gross amount exceeds \$2,500
  - Calendar year 2026 (TY26/PY27) and after: gross amount exceeds \$600

\*Number of transactions threshold has been eliminated.

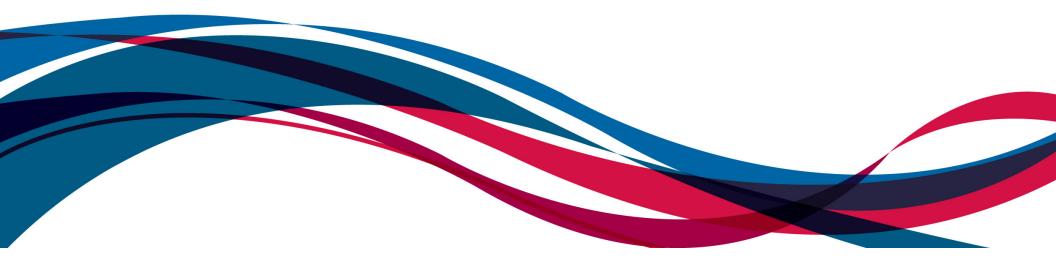
- Form 5498 IRA Contribution Information, is used to report contributions to individual retirement accounts (IRAs)
- ➢ For TY2024 Box 14a and 14b added repayment amounts and codes for:
  - EP (emergency personal expense)
  - DA (domestic abuse victim)
  - TI (terminally ill individual)
- New codes will be available for A2A transmission 01/09/2025
- New codes will be available for Taxpayer portal transmission 02/10/2025

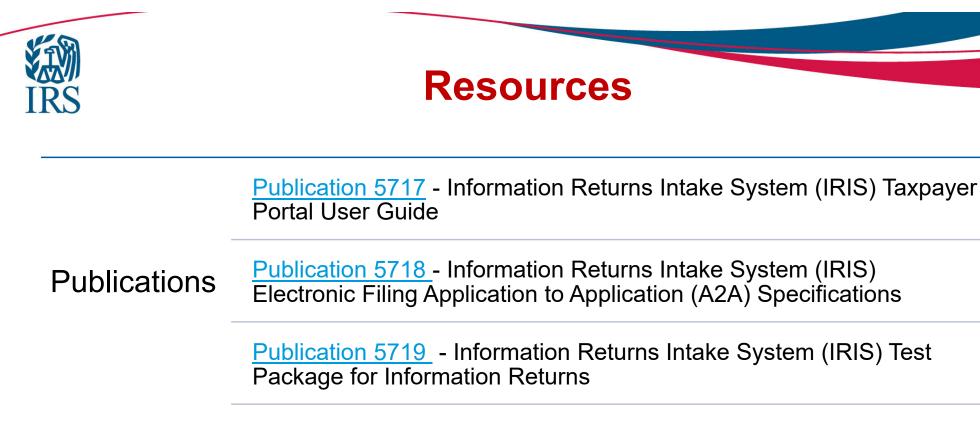
