

# ONGAGE PRIVACY POLICY

*[Last Updated: December 31, 2024]*

This privacy policy (“**Privacy Policy**” or “**Policy**”), describes how Ongage Ltd. (“**Ongage**”, “**we**”, “**us**”, or “**our**”), collect, use and discloses certain information, including your personal data and the choices you can make about that data.

Ongage provides an online email marketing platform, that enables our customers to manage their contacts, send certain email marketing campaigns and much more (“**Services**”).

This Privacy Policy which is incorporated by reference in our [Terms of Service](#) (“**Terms**”), governs the processing and transfer of data collected in connection with: (i) visitors our website, available at: <https://www.ongage.com/> or other official digital assets, such as our social media accounts (“**Visitors**” and “**website**” respectively); (ii) customers who sign up (or log-in) for and use our Services (“**Customer**”); (iii) our Customers’ end users (“**Recipients**”). Customers, Recipients and Visitors will be jointly be referred to as “**Users**” or “**you**”, “**your**”.

This Policy applies to all information about you that we collect in connection with the Services throughout the world, and explains what data we may collect from you, how such data may be used or shared with others, how we safeguard it, and how you may exercise your rights related to your Personal Data (as defined below) under the applicable privacy laws such as the EU General Data Protection Regulation (“**GDPR**”) and the California Consumer Privacy Act (“**CCPA**”).

**California residents**, please review our [CCPA Privacy Notice](#). Under the CCPA, Ongage is considered as “service provider” (as defined therein).

**Specific US States Residents:** Some US States’ privacy laws may apply to you, as further detailed in Section 13 below. Please review this section to learn more about our privacy practices and your rights under the privacy and data protection laws of certain US States.

KINDLY NOTE THAT YOU ARE NOT REQUIRED BY LAW TO PROVIDE US WITH ANY PERSONAL DATA. HOWEVER, SOME OF OUR SERVICES AND SOME OF THE WEBSITE’S FEATURES REQUIRE THE PROCESSING OF CERTAIN PERSONAL DATA, AND WITHOUT SUCH DATA, WE MAY NOT BE ABLE TO PROVIDE YOU WITH ALL OR PART OF OUR SERVICES.

## **1. POLICY AMENDMENTS**

We reserve the right to amend this Policy from time to time, at our sole discretion. The most recent version of the Policy will always be posted on the website. The updated date of the Policy will be reflected in the “Last Updated” heading. We will provide notice to you if these changes are material, and, where required by applicable law, we will obtain your consent. Any amendments to this Policy will become effective within 30-days upon the display of the modified Policy. We recommend you review this Policy periodically to ensure that you understand our most updated privacy practices.

### **3. DATA SETS WE COLLECT AND FOR WHAT PURPOSE**

We may collect two types of information from you, depending on your interaction with us.

The first type of information is non-identifiable and anonymous information (“**Non-Personal Data**”). We are not aware of the identity of the individual from who we have collected the Non-Personal Data. Non-Personal Data which is being gathered consists of technical information, and may contain, among other things, the type of operating system and type of browser, type of device, your action in the website or Services (such as session duration).

The second type of information is individually identifiable information, namely information that identifies an individual or may with reasonable effort identify an individual (“**Personal Data**”).

For the avoidance of doubt, any Non-Personal Data connected or linked to Personal Data shall be deemed as Personal Data as long as such connection or linkage exists.

The table below details the types of Personal Data we process, the purpose, lawful basis, and our processing operations (depending on your interaction with us):

Please note that, the actual **processing operation** per each purpose of use and lawful basis detailed in the table above, may differ. Such processing operation usually includes set of operations, made by automated means, such as collection, storage, use, disclosure by transmission, erasure or destruction. Transfer of Personal Data to

third party countries as further detailed in the Data Transfer section is based on the same lawful basis as stipulated in the table above.

In addition, we may use certain Personal Data to prevent potentially prohibited or illegal activities, fraud, misappropriation, infringements, identity thefts and any other misuse of the Services and to enforce the Terms, as well as to protect the security or integrity of our databases and the Services, and to take precautions against legal liability. Such processing is based on our legitimate interests.

We may collect different categories of Personal Data and Non-Personal Data from you, depending on the nature of your interaction with the Services provided through the website and Platform, as detailed above.

#### **4. HOW WE COLLECT INFORMATION**

we may collect the following information from you:

- **Automatically** – we may use cookies or similar tracking technologies in connection with our website. The way in which we, and third parties placing cookies in connection with the Services, use cookies and collect data, is explained in our [Cookie Policy](#). We further automatically process and collect the Recipient Behaviour Data on behalf of our Customers.
- **Provided by you voluntarily** – we will collect information if and when you choose to provide us with the information, as through the Services, contact us communications, registration, etc.
- **Provided by Third Parties**- as detailed above, our Customers will provide Recipient Contact Information.

#### **5. COOKIES & TRACKING TECHNOLOGIES**

We use “cookies” (or similar tracking technologies) when you access the website or interact with the Services we offer. The use of cookies is a standard industry-wide practice. A “cookie” is a small piece of information that a website assigns and stores on your computer while you are viewing a website. You can find more information about cookies at <http://www.allaboutcookies.org/>.

Cookies can be used for various purposes, including allowing you to navigate between pages efficiently, for statistical purposes, as well as for advertising purposes. You can find more information about our use of cookies, as well as change your settings and preferences, as detailed in our [Cookie Policy](#).

#### **6. DATA SHARING– CATEGORIES OF RECIPIENTS WE SHARE PERSONAL DATA WITH**

We share your Personal Data with third parties, including our partners or service providers that help us provide our Services. You can find in the table below information about the categories of such third-party recipients.

## **7. USER RIGHTS**

We acknowledge that different people have different privacy concerns and preferences. Our goal is to be clear about what information we collect so that you can make meaningful choices about how it is used. We allow you to exercise certain choices, rights, and controls in connection with your information. Depending on your relationship with us, your jurisdiction and the applicable data protection laws that apply to you, you have the right to control and request certain limitations or rights to be executed. Certain rights can be **easily** executed independently by you as follows:

- As our Customer, you can correct certain data provided under your Account (such as contact information) through the account settings;

When you contact us to exercise your rights concerning your Personal Data, we may request certain information from you to verify your identity and locate your data. Please note that, as required or permitted by applicable law, the process of locating your data and processing your request may take a reasonable amount of time and effort. In addition, data privacy and related laws in your jurisdiction may grant you different or additional rights regarding the data we collect from you.

In case you are not satisfied with the way we handle your request, you have the right to file a complaint with the EU Member State supervisory authority.

For additional rights under specific jurisdictions, including US state laws, please refer to the specific regional disclosure below.

## **8. DATA RETENTION**

In general, we retain the Personal Data we collect for as long as it remains necessary for the purposes set forth above, all under the applicable regulation, or until you express your preference to opt-out (where applicable), or terminate your use of the Services, or you request to delete your Personal Data.

Other circumstances in which we will retain your Personal Data for longer periods of time include: (i) where we are required to do so in accordance with legal, regulatory, tax, or accounting requirements; (ii) for us to have an accurate record of your dealings with us in the event of any complaints or challenges; or (iii) if we reasonably believe there is a prospect of litigation relating to your Personal Data. Please note that except as required by applicable law, we may at our sole discretion, delete or amend information from our systems, without notice to you, once we deem it is no longer necessary for such purposes.

## **9. SECURITY MEASURES**

We design our systems with your security and privacy in mind. We have implemented physical, technical, and administrative security measures for the Services that comply with applicable laws and industry standards which you can review our [Security Policy](#) to learn more.

Note that we cannot be held responsible for unauthorized or unintended access beyond our control, and we make no warranty, express, implied, or otherwise, that we will always be able to prevent such access.

## **10. INTERNATIONAL DATA TRANSFER**

Our data servers in which we host and store the information are located in Ireland. The Company’s HQ are based in Israel in which we may access the information stored on such servers or other systems such as the



Company's ERP, CRM, Salesforce, and other systems. We will take appropriate measures to ensure that your Personal Data receives an adequate level of data protection upon its transfer. When Personal Data that was collected within the EEA is transferred outside the EEA, we will take necessary steps in order to ensure that sufficient safeguards are provided during the transferring of such Personal Data. You may exercise your rights, where applicable, to receive information regarding the transfer mechanism that was used during such transfer. Personal Data transferred outside the EEA is transferred, in all cases pursuant to standard contractual clauses approved by the European Union ("**SCCs**"). Additionally, following the withdrawal of the United Kingdom ("UK") from the European Union on January 31, 2020, the UK is no longer considered to be a part of the EEA and therefore, the transferring of Personal Data from the EEA to the UK will also be subject to the SCCs or other contractual clauses that will ensure the security of the Personal Data (pending an adequacy decision from the European Commission).

## **11. THIRD PARTY WEBSITES**

This Privacy Policy governs and applies to the collection and disclosure of Personal Data by us. If you choose to disclose your Personal Data to third parties through our website (for example, by clicking a link to a third-party website), those parties' privacy practices will apply to any data you disclose to, and collected by them, and this Privacy Policy does not extend to their products or services. You acknowledge and agree that we are not responsible and shall bear no liability whatsoever for such third-party websites and your use thereof.

## **12. ELIGIBILITY AND CHILDREN PRIVACY**

The website and the Services are not intended for use by children and we do not knowingly collect or maintain information about anyone under the age of 16. Please contact us at: [dpo@ongage.com](mailto:dpo@ongage.com) if you have reason to believe that a child has shared any data with us.

## **13. REGIONAL US PRIVACY DISCLOSURES**

### **13.1. General Applicability and Jurisdictions**

This section applies to residents of certain US states, subject to applicable state privacy laws, including residents of Virginia, Connecticut, Colorado, Utah, Texas, Oregon and Montana (effective as of October 1, 2024) and residents of Nebraska, New Hampshire, New Jersey, Delaware and Iowa (effective as of January 1, 2025), as such laws may be amended from time to time, including by implementation of regulations and amendments, (collectively: "**US Privacy Laws**"). Any capitalized term not which is not defined in this section shall have the meaning ascribed to it in this Privacy Policy above or as set forth in applicable US Privacy Laws.

Residents of California are referred to our [CCPA Notice](#), which discloses the categories of personal information collected, the purposes of processing, the sources of personal information, the categories of recipients with whom personal information is shared for a business purpose, whether personal information is sold or shared, the retention period, and the methods by which you may exercise your rights as California residents.

The additional disclosures below supplement this Privacy Policy and provides further details to the extent we shall be deemed a "Business" or a "Controller" under applicable US Privacy Laws, for instance, in case we process Visitor's information with respect to their use of the website or as Customers purchasing products via our website.

### **13.2. Personal Information We Process**

In the “**DATA SETS WE COLLECT AND FOR WHAT PURPOSE**” section above, you can find details regarding the categories of Personal Data we collect and process, as well as the purposes for which this data is processed, used or stored. We will not collect additional categories of Personal Data or use the Personal Data collected for materially different, unrelated or incompatible purposes without obtaining your consent.

Depending on your interaction with us as a Visitor or a Customer, the Personal Data we collect may include the following:

- **Contact Communications Information** - this includes your identifiers and contact details (e.g., name, email, phone number), the content of your inquiry, and any additional information you provide voluntarily (e.g., your workplace, position, or country of residence). We collect and process this information to respond to your inquiry and to maintain records of our communications.
- **Online Identifiers and Advertising/Targeting Data** - this includes information such as your IP address, location and time zone settings, operating system and platform, browser plug-in types, domain name and browser type. We process this information for technical website management, analytics, and online marketing activities.
- **Analytics Data** - we may process certain information in an aggregated, statistical and de-identified form to measure the usage of our Services. We do this to improve and further develop and improve our Services.
- **Newsletter and Event Registration Information** - this includes your email address, phone number, and your interactions with the messages and content we send you. We collect and process this information to send you news, process your event participation, and deliver promotional materials and updates about our Services, subject to your consent and applicable law.
- **Job Applicant Information** – if you apply to a job via our website, we will process the information you provide for recruitment purposes.

Under US Privacy Laws, “Personal Data” does not include publicly available information or information that cannot be reasonably linked to you (directly or indirectly), such as de-identified or aggregated data. It also excludes information governed by other state or federal laws, such as: Health or medical information covered by the Health Insurance Portability and Accountability Act of 1996 (HIPAA), Personal Data covered by certain sector-specific privacy laws, including the Fair Credit Reporting Act (FCRA), the Gramm-Leach-Bliley Act (GLBA), and the Driver’s Privacy Protection Act of 1994, Children’s Online Privacy Protection Act of 1998 (COPPA), Family Educational Rights and Privacy Act of 1974, Securities Exchange Act of 1934, higher education data and employment data.

“Sensitive Data” under US Privacy Laws is generally defined as data that reveals racial or ethnic origin, religious beliefs, mental or physical health history and conditions, sex life or sexual orientation, citizenship or immigration status, genetic or biometric data that can be and/or is processed to uniquely identify an individual, precise geolocation or personal data from a known child. As a “Business” or “Controller” of personal data, we do not collect or process any Sensitive Data.

### **13.3. Disclosures of Your Personal Data to Third Parties, and Sale or Sharing of Personal Data**

In the “Data Sharing” section above, you will find details on the categories of third parties with whom we share Personal Data for business purposes.

We do not sell your personal information for profit. However, we do engage in targeted advertising on the website. Under certain US Privacy Laws, certain marketing activities conducted through third parties (e.g., via cookies or similar tracking technologies) may be considered as a “Sale” or “Share.” As common among

online service providers, we permit third-party advertising networks, social media companies and other third-party businesses to collect information directly from your browser or device when you visit or interact with the website, such as Online Identifiers and Advertising/Targeting Data described above. These third parties use your information to deliver targeted advertising (also known as “cross-context behavioral advertising”) and personalized content on our website and other sites and services you may use, and to provide related services such as reporting, attribution, analytics and market research. #### **13.4. Opting Out of Targeted Advertising**

#### **13.5. Exercising Your Privacy Rights**

For security purposes, we may verify your identity and confirm that you granted the agent permission to submit the request. Additional time may be required to fulfill such requests. We may deny a request if we are unable to verify the authorized agent’s authority to act on your behalf. For privacy and security reasons, all subsequent communications will be directed to the individual on whose behalf the request was submitted.

### **13.7. Appeal Rights**

Depending on your state of residency, you may have the right to appeal our decision regarding your privacy rights request.
