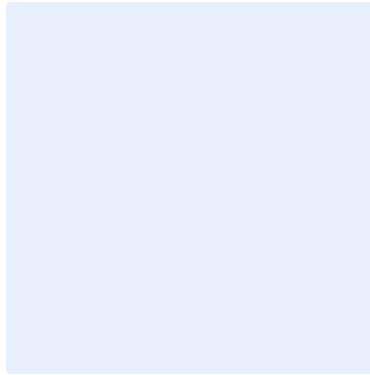

<sup>1</sup> BRIC cost share is typically 75% federal and 25% non-federal; however, local government subapplicants identified in the federal [Justice40](#) or [Community Disaster Resilience Zone \(CDRZ\)](#) programs or that are Economically Disadvantaged Rural Communities (EDRCs) may be eligible for an increased federal share. EDRCs are communities of 3,000 or fewer residents that have an average per capita annual income no more than 80% of the national per capita income based on the best available data.
