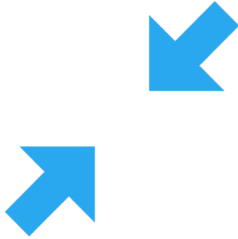
NOW WE MUST MAKE SURE ALL THE GOALS ARE REACHED - IN EUROPE AND GLOBALLY
