TERMS AND CONDITIONS FOR UOB ONE DEBIT VISA CARD NESPRESSO ESSENZA MINI PROMOTION

1. **Promotion**

- 1.1. This UOB One Debit Visa Nespresso Essenza Mini Promotion (the "**Promotion**") is only valid between 1 January 2025 and 28 February 2025, both dates inclusive (the "**Promotion Period**").
- 1.2. By participating in this Promotion, you agree to be bound by the terms and conditions of this Promotion (the "**Terms**").
- 1.3. This Promotion is only open to selected cardmembers of the UOB One Debit Visa Card ("**Eligible Card**") issued by United Overseas Bank Limited ("**UOB**") in Singapore who have received an invitation from UOB to participate in this Promotion.
- 1.4. To participate in this Promotion, you must satisfy all of the following conditions:
 - (a) you must receive an invitation via SMS, electronic direct mail, TMRW app push notification, UOB Personal Internet Banking banner or TMRW app banner from UOB during the Promotion Period inviting you to participate in this Promotion (the "**Invitation**");
 - (b) you must successfully make at least three (3) Eligible Spend using mobile payment transactions (such as Apple Pay, Google Pay or Samsung Pay) charged to your Eligible Card during the Promotion Period; and
 - (c) you must successfully charge at least S\$750 in Eligible Spend to your Eligible Card for two (2) consecutive qualifying periods as set out below during the Promotion Period:
 - (i) The first Qualifying Period is from 1 January 2025 to 31 January 2025 (both dates inclusive).
 - (ii) The second Qualifying Period is from 1 February 2025 to 28 February 2025 (both dates inclusive).
- 1.5. For the purposes of this Promotion:
 - (a) **"Eligible Spend"** shall mean all transactions that are successfully charged and posted to your Eligible Card, but shall exclude the Excluded Transactions (as defined below).
 - (b) **"Excluded Transactions"** refers to the following:
 - (i) any instalment payment plans;
 - (ii) any charges and fees imposed by UOB;
 - (iii) fund transfers to or from a Card account;
 - (iv) unposted/voided/disputed/reversed transactions;

- 1.6. UOB reserves the right, at any time at its sole discretion, to amend or vary the list of Eligible Transactions and the list of Excluded Transactions without any reason or prior notification and/or assuming any liability to any party and shall not be liable to pay any compensation or enter into any correspondence in connection with the same.
- 1.7. A merchant's registered MCC may not always correspond with its nature of business. The MCCs are assigned by the merchant's acquiring bank. UOB does not determine the merchants' MCC. UOB shall not be liable in any way whatsoever relating to the categorisation of a merchant's MCC.

2. Gift

- 2.1. If you are the first 100 participants to satisfy all of the conditions in Clause 1.4 above, you shall be eligible to receive one (1) Nespresso Essenza Mini Pure White (the "**Gift**").

- 2.4. The redemption period for the Gift will be stated in your Notification Email (the "**Redemption Period**"). Strictly no extension of the Redemption Period is allowed. If you do not redeem your Gift during the Redemption Period, your rights to the Gift will be forfeited.
- 2.5. Gifts are on a first-come-first-served basis, whilst stocks last and subject to availability. UOB shall not be required to notify and/or update on the stock availability of the Gift.
- 2.6. You are only entitled to receive one (1) Gift under this Promotion, regardless of the number of Eligible Cards that you may hold.

- 2.7. The Gift is neither transferable nor assignable. The Gift is not exchangeable for cash, credit or kind, in full or in part, and is not replaceable if lost or stolen. No reservation, refund or exchange of the Gift is allowed.
- 2.8. UOB may substitute the Gift with any item of equivalent or similar value, without prior notice or reason or being liable to any person.
- 2.9. UOB reserves the right to decline any redemption of the Gift if any one of the requirements set out in these Terms and the Notification Email are not met at the time of redemption. No replacement will be issued for a lost, stolen or destroyed Notification Email.
- 2.10. The Gift must be redeemed during the redemption period specified in the Notification Email and in accordance with the instructions and terms specified in the Notification Email. UOB will not extend the redemption period for any reason whatsoever. For the avoidance of doubt. Any Gift that is not redeemed by the close of the redemption period shall be forfeited.
- 2.11. The Gift is supplied by third party merchants and UOB is not an agent of the merchant and/or supplier of the Gift. Accordingly, UOB makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Gift and UOB assumes no liability or responsibility for the acts or omissions of the merchants or any non-performance or defects in the Gift. Any dispute regarding the Gift is to be resolved directly with the merchant and/or supplier of the Gift. UOB shall not be required to assist or act on your behalf in communicating with the merchant and/or supplier of the Gift. For the purposes of this clause, "Gift" includes any products and/or services provided by third party merchants in connection with the use and/or redemption of the Gift.
- 2.12. Your Eligible Card account must be in good standing at all times as determine by UOB at its absolute discretion. In the event that your Eligible Card account is delinquent, voluntarily or involuntarily closed or terminated or suspended for any reasons whatsoever before your redemption of the Gift, the Gift shall be forfeited and you shall not be entitled any compensation or payment whatsoever.

3. General

 - (c) individuals who are mentally unsound, facing legal incapacity or are incapable of handling their affairs, deceased, insolvent, bankrupt or have any legal proceedings (or any threat) of any nature instituted against them; or
 - (d) anyone whom UOB may decide to exclude, at its sole discretion, without any reason or prior notice at any time.
- 2. UOB will not be liable or responsible for any injury, loss or damage whatsoever or for any charge, cost or expense of any kind whatsoever suffered or incurred as a result of or in connection with the redemption or usage of any reward under this Promotion or participation in this Promotion. Without limiting the foregoing, UOB will not be liable or responsible for any undelivered, misdirected, corrupted, lost or delayed text, transmission or transaction or any delay or failure in posting any transaction or accessing any of UOB's online banking services or mobile banking services or third party applications, howsoever caused.
- 3. UOB has the absolute right and unfettered discretion to make decisions on all matters relating to or in connection with the Promotion, including but not limited to the determination of whether you have met all the requirements of the Promotion. UOB's decisions shall be final, conclusive and binding and no payment or compensation will be given. UOB shall not be obliged to give any reason or prior notice or enter into any correspondence with any person on any matter or decision relating to the Promotion.

If UOB determines that you are ineligible to participate in this Promotion or to receive any reward under this Promotion, UOB may in its sole discretion forfeit such reward, reclaim the reward or charge to and debit an amount equal to the value of the reward from any of your accounts with UOB without prior notice to you. If the monies standing to the credit of your accounts are insufficient to reimburse UOB, you shall immediately reimburse UOB for the value of the reward through such means as UOB may determine in its sole discretion.
- 5. The Terms shall be read in conjunction with the prevailing UOB Debit Cardmember Agreement and any other terms that may be relevant in connection with this Promotion (collectively the "Standard Terms"). In the event of any inconsistency between (i) the Terms and the Standard Terms, the Terms shall prevail to the extent of such inconsistency; and (ii) the Terms and any advertising, promotional, publicity, brochure, marketing or other materials relating to or in connection with the Promotion, the Terms shall prevail to the extent that such discrepancy relates to this Promotion.
- 6. UOB may, at any time and at its discretion terminate the Promotion and/or amend any of the Terms, and all persons shall be bound by such amendments.
- 7. Unless otherwise stated, this Promotion is not valid with other offers, privileges or promotions.
- 8. By participating in this Promotion and in addition to any other consent you have already provided to UOB and any right of UOB under applicable laws, you consent to UOB and the necessary third

parties collecting, using and disclosing your information (including your personal data) for the purposes of this Promotion and to contact you, including by voice call or text message.

- 9. A person who is not a party to the Terms shall have no rights under the Contracts (Rights of Third Parties) Act 2001 to enforce the Terms.
- 10. The Terms shall be governed by the laws of the Republic of Singapore and you shall be deemed to have agreed to submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
