

Economic Dialogues and Exchanges of Views with Member States under the European Semester Cycles

STATE OF PLAY – November 2022

This table provides a regular update on Member States invited for an Economic Dialogue in the competent Committee of the European Parliament and an overview of the respective legal base.

A Member State may be invited by the European Parliament (EP) for an **Economic Dialogue (ED)** in accordance with one or more of the following procedures:

- > Stability and Growth Pact (SGP)
- > Macroeconomic Imbalance Procedure (MIP)
- > Enhanced surveillance or macroeconomic adjustment programme (Euro Area Member States)
- > Enhanced monitoring of national budgetary plans (Euro Area Member States)

Member States can also be invited to an **exchange of views (EV)** with the European Parliament without reference to any specific EU legal base.

Table 2: An overview of the legal bases for an invitation to an Economic Dialogue

Stability and Growth Pact

Under Article 2-ab on the ED of the [Regulation 1466/97 as amended by Regulation 1175/2011](#) on the **strengthening of the surveillance of budgetary positions and the surveillance and coordination of economic policies** (under Article 121(4) of the TFEU) the competent committee of the EP may offer the opportunity to a MS which is the subject of a Council recommendation under Article 6(2) [Stability Programme for euro area MS - in the event of a significant deviation from medium-term budgetary objective, COM shall address a warning to the MS concerned] or Article 10(2) [Convergence Programme for non-euro area MS - in the event of a significant deviation from medium-term budgetary objective, COM shall address a warning to the MS concerned] of the same Regulation to participate **in an exchange of views**.

Under Article 3 on the ED of the [Regulation 1173/2011](#) on the **effective enforcement of budgetary surveillance in the euro area** the competent committee of the EP may offer the opportunity to the MS concerned by decisions under Articles 4 [sanctions in the preventive arm of the Stability and Growth Pact], 5 [sanctions in the corrective arm of the Stability and Growth Pact] and 6 [fines] of this Regulation to participate **in an exchange of views**.

Under Article 2a on ED of the [Regulation 1467/97 as amended by Regulation 1177/2011](#) on **speeding up the implementation of the excessive deficit procedure**, the competent committee of the EP may invite a MS concerned by the Council decisions under Article 126(6) [decision on the existence of an excessive deficit] TFEU, Council recommendations under Article 126(7) [recommendation addressed to the MS concerned with a view to bringing that situation to an end within a given period] TFEU, notices under Article 126(9) [notice to the MS to take, within a specified time limit, measures for the deficit reduction] TFEU or Council decisions under Article 126(11) [when a MS fails to comply with decision taken in accordance with paragraph 9, the Council may decide to apply additional measures] TFEU to participate **in an exchange of views**.

Macroeconomic Imbalance Procedure

Under Article 14(2) on the ED of the [Regulation 1176/2011](#) on **prevention and correction of macroeconomic imbalances**, the competent committee of the EP may invite a MS, which is the subject of a Council recommendation or decision under Article 7(2) [opening of the excessive imbalance procedure], Article 8(2) [corrective action plan] or Article 10(4) [assessment of corrective action] of the same Regulation to participate **in an exchange of views**.

Under Article 6 on the ED of the [Regulation 1174/2011](#) on **enforcement measures to correct excessive macroeconomic imbalances** in the euro area the competent committee of the EP may offer the opportunity to the MS concerned by decisions of the same Regulation to participate **in an exchange of views**.

Enhanced monitoring of national budgetary plans (Euro Area)

Under Article 15(2) on the ED of the [Regulation 473/2013](#) on **monitoring and assessing draft budgetary plans and ensuring the correction of excessive deficits of the MS in the euro area**, the competent committee of the EP may offer the opportunity to the MS that is the subject of a COM recommendation under Article 11(2) [risk of non-compliance with the deadline to correct the excessive deficit] or Council acts as referred to in paragraph 1(d) [Council opinion on the economic partnership programme or Council decisions under Article 126(8) or Article 126(11) TFEU] to participate **in an exchange of views**.

Enhanced surveillance or macroeconomic adjustment programme (Euro Area)

Under [Regulation 472/2013](#) on the **strengthening of economic and budgetary surveillance of MS in the euro area experiencing or threatened with serious difficulties with respect to their financial stability**:

> **Article 3(8): Enhanced surveillance**

Where a recommendation referred to in paragraph 7 [recommendation to the MS concerned to adopt precautionary corrective measures or to prepare a draft macroeconomic adjustment programme.] is made public:

(a) the competent committee of the EP may offer the opportunity to the MS concerned and to the Commission to participate **in an exchange of views**;

> **Article 7 (10): Macroeconomic adjustment programme**

The competent committee of the EP may offer the opportunity to the MS concerned and to the COM to participate **in an exchange of views** on the progress made in the implementation of the adjustment programme;

> **Article 14 (3): Post-programme surveillance**

The competent committee of the EP may offer the opportunity to the MS concerned to participate **in an exchange of views** on the progress made under post-programme surveillance.
